



COMPREHENSIVE PLAN AMENDMENT APPLICATION

The following items must be submitted by the established deadline dates for consideration:

1. Five fully dimensioned, 8 ½" x 11" color maps showing:
 - a. Land affected;
 - b. Present zoning of property and zoning of adjacent property;
 - c. Current land use plan classification and proposed land use plan changes;
 - d. Current land use plan classification of adjacent property;
 - e. Current and proposed street alignments;
2. Digital copy of map in PDF format;
3. General location and address of property;
4. Total acreage;
5. A fully completed Comprehensive Plan Amendment Request Form;
6. Title Company certified property owners list, and two sets of mailing labels, within 300' of request (unless the application is submitted with a Preliminary Plat application); and
7. Application fee (\$500).

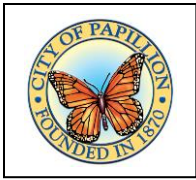
