**SYNOPSIS**

St. Columbkille Church, 200 East 6<sup>th</sup> Street, Papillion, NE 68046, has submitted Special Designated Liquor License applications for events to be held at the church on March 8, 2019, March 15, 2019, March 22, 2019, March 29, 2019, April 5, 2019, and April 12, 2019, from 4:00 PM to 10:00 PM each day with an estimated crowd of 1,200 people.

**FISCAL IMPACT**

\$40.00/day – Application fee - payable to the Nebraska Liquor Control Commission  
\$60.00/day – Occupation tax - payable to the City of Papillion

**BACKGROUND**

Section 53-124 of the Nebraska Liquor Control Act requires all applicants for special designated liquor permits to obtain approval from the local governing body. Non-profit organizations are allowed six permits each year. The NLCC requires all applications for special designated permits to arrive at their office a minimum of 10 days prior to the scheduled event.

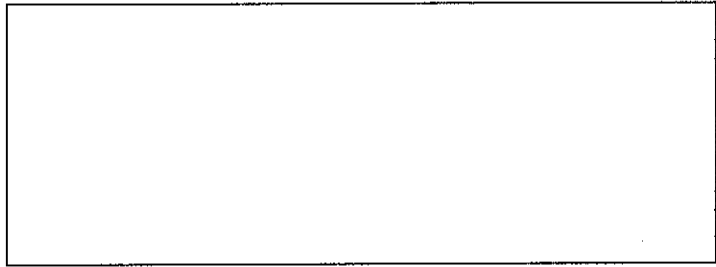
