SYNOPSIS

Trusty Bolt Inc d/b/a Wine Cellar 510, 7474 Towne Center Pkwy Ste 105, Papillion, NE is requesting Special Designated Liquor Licenses for the Sounds of Summer Concert Series to be held at the Shadow Lake Towne Center Amphitheater, 7775 Olson Drive, on May 31, 2019, July 5, 2019, and July 26, 2019, with alternate dates of June 21, 2019, July 19, 2019, and August 2, 2019, respectively, from 5:00-9:00 PM each day with an estimated crowd of 500 people.

BACKGROUND

Section 53-124.11 of the Nebraska Liquor Control Act requires all applicants for special designated liquor permits to obtain approval from the local governing body. The NLCC requires all special designated permits to arrive at their office a minimum of 10 days prior to the scheduled event. Class "K" licenses are allowed unlimited permits each year. Wine Cellar 510 has a Class "CK" liquor license.
