SYNOPSIS

Polish Home, Inc. d/b/a The Belvedere, 201 E 1st Street, Papillion, NE has submitted a Special Designated Liquor License Application for an outdoor polka dance on Friday, June 18, 2021, from 5:00 PM to 11:00 PM during Papillion Days. The applicant expects an estimated crowd of 250 people.

Pursuant to the requirements outlined in RES. R19-0033 which named the City Clerk as Designated Agent for providing local approval with regard to Special Designated Liquor Licenses, this application is being provided to the Council for approval due to the potential for outdoor amplified sound after 10:00 PM.

The applicant has also submitted a request to the Police Department for waiver of the City's noise ordinance relative to this event. The Interim Chief of Police approved the waiver on May 10, 2021.

FISCAL IMPACT

\$40.00/day – Application fee payable to the Nebraska Liquor Control Commission
\$60.00/day – Occupation tax payable to the City of Papillion.

RECOMMENDATION

BACKGROUND

Section 53-124.11 of the Nebraska Liquor Control Act requires all applicants for special designated liquor permits to obtain approval from the local governing body and are allowed six permits each year. The NLCC requires all special designated permits to arrive at their office a minimum of 10 days prior to the scheduled event. Polish Home, Inc. has a Class "C" Liquor License.
